**MEMBER’S RELEASE AND ASSUMPTION OF RISK**

BUCKHORN SKI CLUB, INC. (HEREINAFTER CALLED “CLUB”) IS A NON-PROFIT CORPORATION WHICH ENGAGES IN SKIING AND OTHER ACTIVITIES AND, PURSUANT TO A SPECIAL USE PERMIT ISSUED BY THE UNITED STATES, OPERATES A LODGE FOR THE USE OF ITS MEMBERS AND THEIR FAMILIES AND GUESTS. SUCH OPERATIONS AND ACTIVITIES ARE NORMALLY PERFORMED BY VOLUNTEERS ACTING WITHOUT COMPENSATION AND THE COSTS THEREOF ARE SHARED AMONG MEMBERS AND PARTICIPANTS. IT IS THE PURPOSE OF THIS AGREEMENT THAT EACH PERSON USING THE CLUB FACILITY OR PARTICIPATING IN CLUB ACTIVITIES (RATHER THAN THE CLUB, ITS MEMBERS AND AGENTS AND THE UNITED STATES) ASSUME THE RISK OF PERSONAL INJURY (INCLUDING WRONGFUL DEATH) OR PROPERTY DAMAGE RELATED THERETO REGARDLESS OF RESPONSIBILITY FOR NEGLIGENCE.

THE UNDERSIGNED\* FOR THEMSELVES AND ALL CHILDREN RELEASE AND AGREE TO HOLD HARMLESS THE CLUB, ITS MEMBERS AND AGENTS AND THE UNITED STATES FROM ANY CLAIM AND LIABILITY FOR AND ASSUME THE RISK OF PERSONAL INJURY (INCLUDING WRONGFUL DEATH) AND PROPERTY DAMAGE TO US AND TO MEMBERS OF OUR FAMILY ARISING FROM CLUB ACITIVITIES, OPERATION OF THE CLUB’S SKI FACILITY, OR OUR USE OF THE CLUB’S SKI FACILITY, REGARDLESS OF RESPONSIBILITY FOR NEGLIGENCE.

THE UNDERSIGNED ALSO AGREE TO FURNISH A “GUEST RELEASE AND ASSUMPTION OF RISK” FROM EACH OF OUR ADULT GUESTS AND THE PARENTS OR GUARDIAN OF OUR MINOR GUESTS AND TO HOLD THE CLUB, ITS MEMBERS, AND AGENTS HARMLESS FROM ANY CLAIM AND LIABILITY RESULTING FROM OUR FAILURE TO DO SO. THIS AGREEMENT SHALL BE EFFECTIVE UNTIL 30 DAYS AFTER WRITTEN CANCELLATION IS RECEIVED BY THE CLUB.
